

# Frameless Glass Shower Doors Warranty

When you invest in a frameless glass shower enclosure from AMG Glass & Metal, you're getting a high-performing, long-lasting product expertly constructed of the best materials available, and we're proud to back that up with a warranty you can rely on.

## One-Year Warranty

AMG Glass & Metal guarantees all of its sales and installations and will repair or replace any faulty glass or hardware for a period of (1) year from the date of installation.

This includes service for caulking, leaking, squeaking, and sagging of any shower installation that we have performed.

This warranty does not cover mold or mildew that accumulates on silicone between glass panels or hardware through lack of proper cleaning or customer chips glass.

If we make repairs to your product within the 1-year warranty, your warranty will continue to remain in effect for its original duration. The repairs themselves will have a 90-day warranty, so if something goes wrong with a repair within 90 days, we will repair it free of charge.

## Hardware Warranty

When it comes to hardware, AMG Glass & Metal is proud to work with the best manufacturers in the business. Here are the terms and conditions regarding our warranty on hardware:

- AMG Glass & Metal warrants that for a period of one (1) year following the date of sale, our shower door hinges are warranted against material defects and defects in workmanship. All warranty claims are subject to inspection by AMG Glass & Metal prior to providing a remedy for the warranty claim.
- This Warranty will not apply if, after inspection, it is determined that the shower door hinges have been installed and maintained in a manner that is not in conformity with the instructions and guidelines set forth by AMG Glass & Metal for proper installation and maintenance.
- AMG Glass & Metal's responsibility to provide a remedy under this warranty shall be limited to either a refund of the purchase price, or to provide a replacement of a shower door hinge. The refund or replacement shall constitute the limit of AMG

Glass & Metal's liability and obligation for any material defect or defect in workmanship in a Shower Door Hinge.

- This Warranty is exclusive, and AMG Glass & Metal makes no other warranty, express or implied, including without limitation, any implied warranty of merchantability or fitness for a particular purpose. In no event shall AMG Glass & Metal be liable under any legal theory (including but not limited to contract, negligence, strict liability in tort, or warranty of any kind) for any indirect, special, incidental, consequential, or exemplary damages (including but not limited to lost profits).
- Our warranty is offered only to the original purchaser; that is, the warranty may not be assigned or transferred to someone else, and it terminates upon sale of the home/building in which the product has been installed. We do require proof of ownership.

## Sweeps, Seals, and Doorstops

Acrylic sweeps, seals, and doorstops are covered for a period of one (1) year from the time of installation. Keep in mind that replacement of these materials is considered routine maintenance of the glass shower door and needs to be done periodically; therefore, they are considered the owner's responsibility after the initial warranty has expired. These materials are readily available for purchase from AMG Glass & Metal, and are easily replaced by the homeowner.

## Guardian Shower Guard®

### Warranty

Original customer must register for Shower Guard® warranty through the provided instructions within 90 days of purchase to activate warranty. This warranty is exclusively offered by Guardian, not AMG Glass & Metal. When registered as required, installed as part of an indoor shower enclosure, and regularly maintained according to Guardian's recommendations according to water type, Guardian Shower Guard glass is warranted to the Original End-user Customer to be free from visible staining, corrosion, or discoloration under normal use for as long as the Original End-user owns the shower in the original property where the shower enclosure was installed. Liability under this Limited Warranty is limited, at Guardian's exclusive option, to Guardian furnishing replacement Shower Guard glass or refunding the difference in the Original End-user Customer's purchase price between Shower Guard glass and standard glass, up to a maximum of \$10.00 per square foot. If Guardian furnishes replacement Shower Guard glass under this Limited Warranty, the warranty coverage will extend to the replacement glass.
